

# CERTIFIED RECORD OF LAND CORNER MONUMENTATION

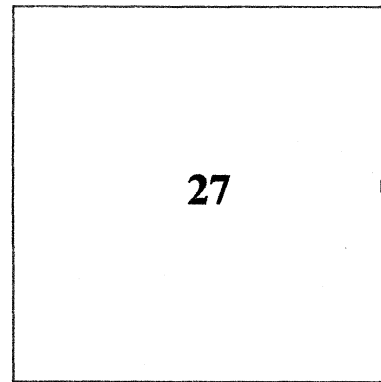
## History of original corner establishment:

Corner established by Odell and Gray in 1867 under GLO contract number 120, dated February 7, 1868.

### Record states:

Set ¼ sec cor. drove charred stake and raised stone mound as per instructions.

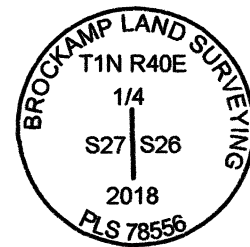


## Subsequent survey:

Corner recovered in 1992 as per CS NO. 043-1992 by James H. Hambleton, PLS 645 as filed in the Union County Surveyor's office.

### Record states:

Found mound of stone at an ancient four-way fence corner that fits very closely to what the original GLO notes call for. No evidence of the original post. Billy Hindman local long-time rancher had knowledge of this corner.



## Description of evidence found:

Found none

## Description of monument and accessories established to perpetuate the location of this corner.

Corner positioned by single proportion as per survey 023-2023, set an aluminum pipe, 2 ½ ins. diam., firmly set, projecting out of the ground 5 ins. in a collar of stone, with 3 ¼ ins. aluminum cap mkd. as shown.

### New Accessories:

A basalt stone, 1 ft. by 2 ft. by 2 ft., bears N., 54.7 ft. dist., marked XBO 1.

A basalt stone, 1 ft. by 1 ft. by 1 ft., bears S 58° E., 200.3 ft. dist., marked XBO 2.

An iron rod, 5/8 ins. diam., by 30 ins. long, with aluminum cap, 2 ins. diam. marked RM 1, bears S. 34°W., 9.2 ft. dist.

An iron rod, 5/8 ins. diam., by 30 ins. long, with aluminum cap, 2 ins. diam. marked RM 2, bears N. 21°W., 7.4 ft. dist.

Bearings are made with a hand compass, magnetic declination = 15°E.
