#### History of original corner establishment:

Frank W. Campbell, 1883, Contract No. 468 Set a basalt stone 10 x 10 x 7 ins. 7 ins. In the ground, marked 1/4 on W face, from which:

A fir 6 inch in dia. bears N 45° E 56 lks. (37.0 ft.) dist. marked 1/4S BT

A fir 12 inch in dia. bears N 35° W 65 lks. (42.9 ft.) dist. marked 1/4S BT

#### Description of corner evidence found:

Found no trace of the original monument or its accessories.

### Description of monument and accessories I established to perpetuate the original location of this corner:

Monument Set:

At the single proportionate position I set a standard U.S.F.S. monument (3 1/4 in. x 30 in. diam. aluminum cap on a 2 1/2 in. aluminum pipe), buried 26 ins. in the ground with a rock collar and a magnet at its base. Guard post with Land Survey Monument sign northerly 4.0 ft.

Accessories Set:

A white fir, 26 ins. diam. bears N 61° E 26.7 ft. marked 1/4 S5 BT with a brass washer marked PLS 2456 on a double blaze.

A white fir, 6 ins. diam., bears S 70 1/4° E 10.5 ft. marked X BT with a brass washer marked PLS 2456 on a double blaze.

An Englemann spruce, 14 ins. diam., bears S 47 3/4° W 19.2 ft. marked 1/4 S6 BT with a brass washer marked PLS 2456 on a double blaze.

A white fir, 8 ins. diam., bears N 44 1/4° W 36.5 ft. marked X BT with a brass washer marked PLS 2456 on a double blaze.

Signs, red paint and nail side center on bearing trees.
