In 2003 a dependant resurvey was made by BLM under special instructions dated April 29, 2003. **BLM notes state: Point of 1/4 sec. cor. of secs. 20 and 21, at proportionate dist., there is no remaining evidence of the original cor. Set a stainless steel post, 28 ins. long 2 ½ ins. diam., 26 ins. in the ground, in a collar of stone,

with brass cap mkd. From which a fir 6 ins. diam., bears S74 1/2°E., 24.2 ft. dist., mkd. 1/4 S21 BT. A tamarack 21 ins. diam., bears N7 3/4°W., 7.3 ft. dist., mkd. 1/4 S20 BT. Deposited a magnet in white plastic case at the base of the stainless steel post.

Description of corner evidence found:

Found 2 1/2" o.d. stainless steel pipe with 3 1/4" brass set flush with ground in a 3 ½ ft. dia. mound of stone. Cap marked as shown in diagram. A 22" dia. tamarack with scribes visible on open single blaze bears N7 3/4°W - 7.3 ft. 54-9 and BLM BT signs attached. A 7" dia. White fir with scribes visible on open single blaze bears S74 1/2°E - 24.2 ft. 54-9 and BLM BT signs attached. There is a steel fence post with 54-9 and 54-2 signs 5 ft. south and a steel fence post with 54-2 sign 15 ft. north of corner.

I add two new bearing trees.

A 6" white fir scribed 1/4 S20 BT on double blaze bears N60 3/4°W - 9.2 ft. Nailed 3/4" dia. brass washer stamped "PLS 1106" to face of blaze. Attached signs 54-3 and 54-9 to tree. Painted blaze and a 6" red band around tree.

A 20" white fir scribed 1/4 S21 BT on double blaze bears S10 $^{\circ}$ E - 23.1 ft. Nailed 3/4" dia. brass washer stamped "PLS 1106" to face of blaze. Attached signs 54-3 and 54-9 to tree. Painted blaze and a 6" red band around tree.

Painted blaze and 6" red band around existing bearing trees.

This corner was maintained on Nov 3, 2004. Used magnetic compass with 18° East declination and measured to accessories with a steel tape. Measurements to bearing trees are to the center of tree.
