NEW BEARING OBJECTS:

A $5/8" \times 30"$ rebar with 1 ½" aluminum cap bears N45°10'E, a distance of 28.69 feet, marked "BGB SURVEY MARKER NE RP".

A 4" steel pipe fence post, bears North 16°28'West, 53.01 feet.

A 4" irrigation riser set in concrete bears S19°49'W, a distance of 32.35 feet.

A 5/8" x 30" rebar with 1 $\frac{1}{2}$ " aluminum cap bears S24°24'E, a distance of 23.16 feet, marked "BGB SURVEY MARKER NW RP".




