A 15" pine bears S 1 W, 191 1ks., mkd. S 9 BT.

A 10" pine bears N 51 E, 140 lks. mkd. R 40 E S 3 BT.

Description of corner evidence found:

At assumed corner location I found 20 \times 10 \times 7" basalt stone 10" above ground in good condition with 5 notches on S and 3 notches on E.

Found approx. 36" charred pine stump bears N 34 W, 78 lks.

Found approx. 30" pine stump bears N 51 E, 140 lks. with BT scribed on blaze face.

Found approx. 22" pine snag bears S 01 W, 191 lks. with blaze partially grown over; scribing visible.

Found raised mound of stone along side cor. stone.

Description of monument and accessories I established to perpetuate the original location of this corner

I set a 2" galv. iron pipe with brass cap approx. 6" above surface of ground in a mound of stone 3 ft. dia. and 1 ft. high; buried original stone upside down along west side of pipe. Cap stamped as shown above.
