CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishments

Corner was established in 1882 by Henry Meldrum, Deputy Surveyor under Contract No. 450.

Surveyor General's records state:

Set post 4'long, 4" sq., 24" in the ground for cor. to secs. 1, 12, 6 & 7, mkd. T 1 S S 1 on NW., R 40 E S 12 on SW., R 41 E S 7 on SE., and T 1 S S 6 on NE, with 5 notches on S and 1 on N edge from which: A 26" tamarack bears N 59 E, 22 lks. mkd. T 1 S S 6 BT. A 12" fir bears N 63 W, 6 lks. mkd. T 1 S S 1 BT. A 4" fir bears S 33 W, 4 lks. mkd R 40 E S 12 BT.

A 4" fir bears S 49 E, 5 lks. mkd R 41 E S 7 BT.

Resurveyed by Alonzo Gesner, Deputy Surveyor under Contract No. 683 in 1898. He states that he found a post, 24" above ground, mkd. and witnessed as described by the surveyor general, except the bearing tree in sec. 12. He set:

A 30" fir bears S 58 15 W. 64 1ks. mkd. T 1 S R 40 E S 12 BT.

At assumed corner location I found a 4" x 4" x 12" long wooden post setting 12" above ground level in a small mound of stone. It was rotted off at ground level and in poor condition. It was marked S 12 on SW face and S 1 on NW face; no other scribing visible. Found alive 19" D. Fir bears N 63 W, 6 lks. and with blazed face grown completely over. Someone started to open face several years ago.

Found alive 40" white fir bears S 58 15 W, 64 lks. mkd. T 1 S R 40 E S 12 BT visible. Tree is in poor condition.

Description of monument and accessories I established to perpetuate the original location of this corner

I set a 2" galv. iron pipe with brass cap and stamped as shown above. Monument is 3" above surface in a mound of stone and earth.

Set one new bearing tree in S 12: A 11" lodge pole pine bears S 29 W, 65.25 ft. scribed T 1 S R 40 E S 12 SC BT.
