

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

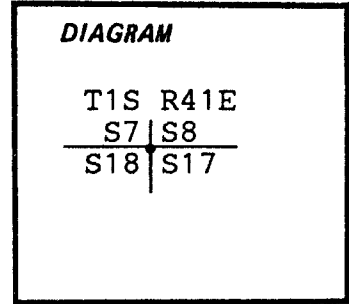

History of original corner establishment:

Original corner established in 1898 by A. Gesner under contract #683.

At the corner, he set a Basalt stone, 18"x8"x6", 12" in the ground. From which:

- A 28" Pine bears N76°E, 24 lks.
- A 24" Yellow Pine bears S64°E, 52 lks.
- A 10" Yellow Pine bears S20½°W, 36 lks.
- A 7" Fir bears N68½°W, 8 lks.



Description of corner evidence found:

No corner monument found.

BT's Found:

- A 17" Doug. Fir bears N68½°W, 8 lks. I opened blaze, S visible, 89 growth rings to blaze.
- A Pine root crown bears S64°E, 52 lks, no marks.
- Found badly decayed pine in SW quadrant, no marks.

Description of monument and accessories established to perpetuate the original location of this corner:

From evidence, I set a 2½"x30" aluminum capped aluminum pipe rising 18" in mound of stones. Set a steel fencepost 3' north of corner.

New BT's:

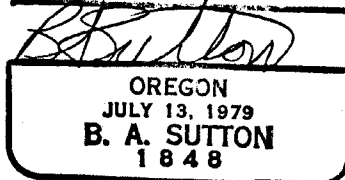
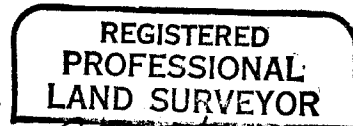
- A 13" Doug Fir bears N17°E, 75.8 ft., blazed&scribed: T1SR41ES8BT
- A 7" White Fir bears S28°W, 9.5 ft., blazed&scribed: T1SR41ES18BT
- An 11½" Doug Fir bears S4°E, 21.2 ft., blazed&scribed: T1SR41ES17BT

Painted blazes and attached signs as per Standard Specifications for Cadastral Surveys, USFS Region 6, March 1982. A ¼" brass disk stamped "RLS 1848" was nailed to the lower ends of the blazes.

From 6200 follow 6200520 southerly 3/8 mile. Corner is on West shoulder of road on steep fill embankment.
