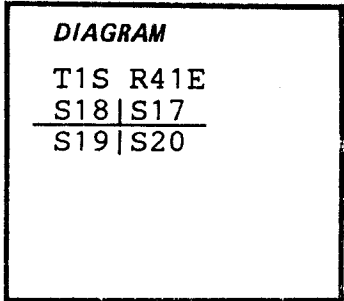


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Index File No. N-05

History of original corner establishment:
Original corner established in 1898 by A. Gesner
under contract #683.
He set a basalt stone, 12"x11"x7", 8" in ground.
From which:
A 9" Spruce bears N17 1/2°E, 101 lks.
An 8" W. Fir bears S51°E, 115 lks.
An 8" Tamarack bears S86°W, 147 lks.
A 9" W. Fir bears N65°W, 147 lks.



Description of corner evidence found:

Found original stone with 5 notches on east and 1 notch on south.

Bearing trees found:

- A 32" Fir bears N65°W, 94.6 ft., hollow center, blaze & scribing visible: 1SR.
An 11 1/2" W. Larch bears S86°W, 96.4 ft., dead standing, scribing visible: T1SR41E 1 BT.
A root hole bears N17 1/2°E, 66.7 ft.
A 21 1/2" Fir bears S51°E, 75.9 ft., blaze healed.

Description of monument and accessories established to perpetuate the original location of this corner:

From evidence, set 2 1/2"x30" aluminum capped aluminum pipe rising 6" above ground. Deposited original stone in hole along north side of cap. Set steel fence post 2 1/2 ft. north of corner.

- A 9 1/2" W. Larch bears N55 1/2°W, 4.9 ft., blazed&scribed: T1SR41ES18BT
A 9 1/2" W. Larch bears N35°E, 36.9 ft., blazed&scribed: T1SR41ES17BT
A 7" W. Larch bears S10 1/2°W, 58.2 ft., blazed & scribed: T1SR41ES19BT

Painted blazes and attached signs as required in Specifications for Cadastral Surveys, USFS Region 6, March, 1982. A 3/4" brass disk stamped "LS1848" nailed to lower end of blazes. From 6200 follow 6200470 westerly 1/2 mile to yellow tag on left, corner is 200 ft. S on knoll.
