

**CERTIFIED RECORD OF LAND CORNER MONUMENTATION**

**History of original corner establishment:**

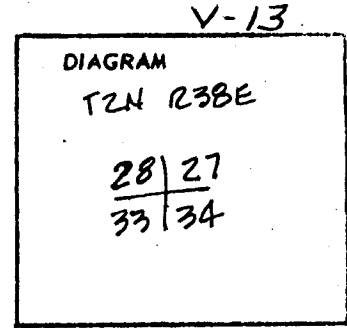
Corner established in 1883 by Frank W. Campbell under Contract No. 468.

80.00 chains. Set fir post 4½' long, 4" square, with marked stone 24" in the ground marked T 2N , S 27 on Northeast face, R 38E S 34 on Southeast face, S 28 on Northwest face, and S 33 on Southwest face with 1 notch on South edge and 3 notches on East edge. From which:

- A fir 18" in diam. bears N 30° E 48 lks. marked T 2N R 38E S 27 BT.
- A fir 10" in diam. bears S 23° E 11 lks. marked T 2N R 38E S 34 BT.
- A fir 10" in diam. bears S 23° W 11 lks. marked T 2N R 38E S 33 BT.
- A fir 20" in diam. bears N 16° W 24 lks. marked T 2N R 38E S 28 BT.

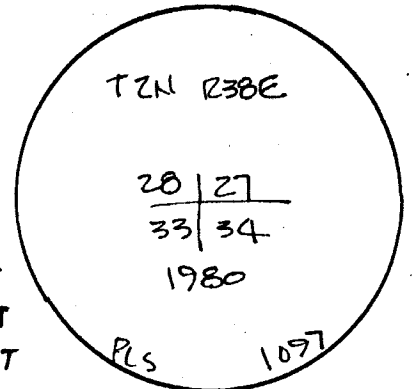

**Description of monument and accessories I established to perpetuate the original location of this corner**

At the position described above, I set a 2½" x 30" aluminum pipe 26" in the ground with an aluminum cap marked as shown.

**From which I scribed BTs:**

| Fir 6" S 50° 25' E  | 9.8 Ft. marked  | T 2N R 38E S 34 BT |
| Fir 6" S 71° 50' W  | 29.9 Ft. marked | T 2N R 38E S 33 BT |
| Fir 10" N 27° 34' W | 9.3 Ft. marked  | T 2N R 38E S 28 BT |



I nailed a brass washer marked OPLS 1097 to BT blazes.

I set a steel fence post 5' North with signs 54-4 & 54-2 & 5' East with sign 54-2

I painted a red band around BTs and face of scribe.

I used a steel tape and T-2 Theodolite to measure to the center of BT
