

There is an E-W fence line 28 feet south.


HISTORY OF ORIGINAL CORNER ESTABLISHED:

Corner previously established by Survey 015-1992 by Duane Griffith. Union County Monumentation Record states: At position determined by survey, I set a 5/8" x 30" rebar with aluminum cap marked as shown, 26" in the ground stone, from which:

A 9" Douglas Fir bears S32°E, 13.95 feet, marked

A 12" Douglas Fir bears N5°E, 9.48 feet, marked NE 1/16 S 10 BT

Set steel fence post 1 foot South



DESCRIPTION OF CORNER EVIDENCE FOUND:

At computed position by survey, I find no trace of the rebar or cap. From said position:

A 16" Douglas Fir bears North 5° East, a distance of 9.50 feet, with healed blaze and remnants of red paint

A 9" Douglas Fir, dead and down, the center which bears South 32° East, a distance of 14 feet, with X BT scribe visible.

A fence post with pink flagging bears Southerly approx. 28 feet, lying horizontally and utilized in a fence corner

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At position determined by survey, I set a 5/8" \times 30" iron pin, 27" in the ground, with a 2 1/2" aluminum cap marked as shown, and in a 1.5 ft. diam. collar of stone, from which:

NEW BEARING OBJECTS:


A 7" Douglas Fir bears South 57° East, a dist. of 15.2 feet, marked NE 1/16 S10 BT.

I used a steel tape and magnetic compass in the establishment of the new accessories. I used a magnetic declination of 14° East. Distances are to a 60d spike driven into the right side base of tree. Bearings are to a brass washer marked OPLS 83571 in the BT blaze of the new bearing tree.
