CERTIFIED RECORD OF LAND CORNER MONUMENTATION

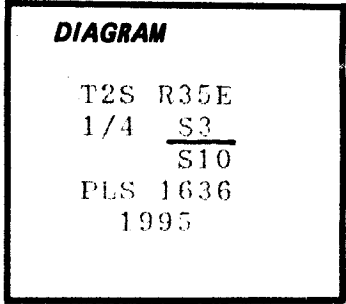

History of original corner establishment:

Original corner established by Rufus S. Moore on September 25, 1882, under contract No. 451 as follows:

Set a basalt stone, 18" x 10" x 8", 12" into the ground, marked 1/4 on north face, from which:

- A 18" fir bears N50°W, 36 links (23.76 feet).
- A 24" fir bears S50°W, 16 links (10.56 feet).



Description of corner evidence found:

Found original corner stone set loosely in the ground 6". The stone measures 18" x 11" x 9" and is plainly marked "1/4" on the fat end. A mound of stones surrounds the corner stone.

There is no trace of the original bearing trees.

Description of monument and accessories I established to perpetuate the original location of this corner:

In place of the original corner stone, I set a 1" x 30" iron pipe 22" into the ground with a 2 1/2" brass cap attached. The cap is marked as shown in the diagram above. I bury the corner stone up-side-down along the northwest side of the pipe. From which:

- A 15" Douglas-fir bears N58°E, 10.7 feet scribed "1/4 S3 BT".
- A 12" Douglas-fir bears S27°30'E, 6.2 feet scribed "1/4 S10 BT".
- A 10" Ponderosa Pine bears S50°30'W, 24.0 feet scribed "1/4 S10 BT".
- A 16" Ponderosa Pine bears N47°W, 48.9 feet scribed "1/4 S3 BT".

The new bearing trees have a 5/8" brass washer, marked "PLS 1636", nailed flush to the lower of double blazes and have a "bearing tree" sign nailed above the blazes.

I hereby certify the above corner position was perpetuated as hereon described on August 5, 1995. Declination: 18°E.
