

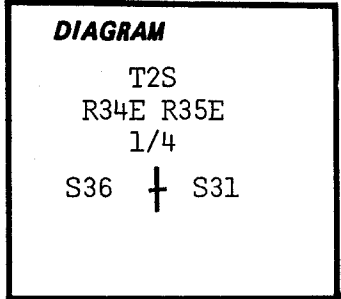
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

X-1 (T2S R35E)

History of original corner establishment:

Corner was originally established by Rufus S Moore under GLO contract No. 461 during November, 1882. Corner was recovered by L. Wilkes surveying under group #38. Surveyor General's notes state: "Intersect the point for 1/4 sec. cor., located by reference to the bearing trees as described by the surveyor general. except that the Se. tree is now dead. I perpetuate this cor., as follows: at the exact cor. point; Set a volcanic stone, 20x12x10 ins., 16 ins. in the ground for 1/4 sec. cor., marked 1/4 36 on W. and 31 on E. face; from which: A tamarack, 16 ins. diam. bears N66°45'W, 67 lks. dist., marked 1/4 S B T (old BT). A tamarack, 6 ins. diam. bears S50°E., 20 lks. dist., marked 1/4 S B T (new BT)."

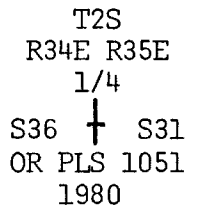


Description of corner evidence found:

Found 3" X 24" wood post in mound of stone scribed 1/4S. In center of mound found set 24" X 12" X 10" stone, clearly marked 1/4 on west side. From which: A 24" tamarac, bears S68°W, 43.7 ft., with grown over blazes. A dead 10" tamarac bears S50°E, 13.3 ft. with grown over blazes.

Description of monument and accessories I established to perpetuate the original location of this corner:

At center of above stone set 2 1/2" X 30" galvanized pipe and brass cap marked: Set pipe 26" in the ground and mound of stone around to cap. Placed marked stone at base of pipe. From which by magnetic declination of N20°E: A 12" pine bears S45°E, 31.7 ft. scribed 1/4S31 BT. Painted blazes red and 6" red band around. Placed 54-3s and 54-4s on old and new BTs. Placed brass washers stamped PLS 1051 on new BT. Placed 54-2 and 54-4 on steel fence post 5' north of the corner.
