CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: This corner was originally established by Jacob C. Cooper on September 9, 1881, under G.L.O. Contract No. 397, as follows:

At the corner point I marked a 8" pine for closing corner: "CC R37E" on the East "T2S S6" on the South and "T1S S31" on the North faces with six notches on the NE and

A 7" Pine N70°E, 40 links (26.4 ft.) marked "T1S R37E S31 BT" A 4" Pine S23°E, 7 links (4.6 ft.) marked "T2S R37E S6 BT"

There is no record of subsequent renewals.

Description of corner evidence found: Original corner tree is down and decayed. I can make out scribing on two faces. Readable scribes include "CC" over six horizontal lines (notches). There is a definite stump hole of about 10-inch diameter where the corner tree once stood.

The only thing which remains of the original B.T.'s are the stump holes in the soil where the trees once stood. These holes are very definite marks on the ground and bear:

N64°E, 26.4 ft. and S35°E, 5.5 ft.

Description of monument and accessories I established to perpetuate the original location of this corner:

In the center of the original corner tree stump hole I set a $2\frac{1}{2}$ " x 30" Aluminum pipe with a $2\frac{1}{2}$ " Aluminum cap attached, 26" into the ground. The cap is marked:

T1S R | S31 C R 3 S1 | S6 C 7 E | T2S E 1986 PLS 1636

From which:

A 21" ponderosa pine bears N58°E, 43.8 ft. Scribed "T1S R37E S31 CC BT" on a single blaze.

A 14" western larch bears S1°W, 39.5 ft. Scribed T2S R37E S6 CC BT" on a single blaze.

Both trees have a 3/4" brass washer, marked "PLS 1636", nailed to the blaze between the scribes "BT." A 54-3 and 54-4 sign are attached to each tree.
