

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

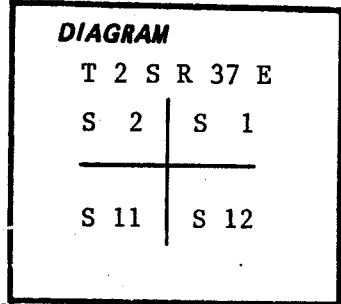
History of original corner establishment:

Corner established by Henry Meldrum under GLO contract no. 450 dated June 11, 1882.

Surveyor General records state:

Set post 4 ft long 4 ins square 24 ins in the ground for cor to Secs 1, 2, 11 & 12 marked T 2 S S 1 on NE, R 37 E S 2 on NW, S 11 on SW and S 12 on SE with 5 notches on S and 1 notch on E edges, from which

- A pine 8 ins diam bears N 42° W, 19 lks dist marked R 37 E S 2 BT
- A pine 9 ins diam bears N 37° E, 12 lks dist marked T 2 S S 1 BT
- A pine 36 ins diam bears S 23° E, 21 lks dist marked S 12 BT
- A pine 6 ins diam bears S 48° W, 43 lks dist marked S 11 BT



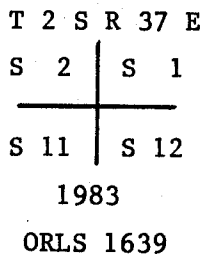
Description of corner evidence found:

Description of monument and accessories established to perpetuate the original location of this corner:

At position established by proportionate measurement from found corners 1/2 mile North, 1 mile South, 1 mile East and 1/2 mile West, set a 2 1/2 inch brass cap on a 2 inch iron pipe 31 inches long and projecting 4 inches out of the ground with a surrounding rock mound and a 6 foot steel fence post alongside with a sign 54-4 attached.

Brass cap marked thus:



New bearing trees established:

- A tamarack 8 ins diam bears N 02° E, 27.7 ft dist marked T 2 S R 37 E S 1 BT
- A fir 8 ins diam bears S 38° E, 17.8 ft dist marked T 2 S R 37 E S 12 BT
- A fir 7 ins diam bears S 20° W, 14.8 ft dist marked T 2 S R 37 E S 11 BT
- A fir 17 ins diam bears N 88° W, 46.8 ft dist marked T 2 S R 37 E S 2 BT

Each new bearing tree has a sign 54-3 attached below a 6 inch band of red paint and has a brass washer marked PLS 1639 nailed flush with BT blaze. A sign 54-4 is attached on the opposite side of tree from BT blaze.
