Found a stone $19 \times 15 \times 4$ ins marked 1/4 and lying loose on the ground.

No trace of section 12 bearing tree.

Description of monument and accessories I established to perpetuate the original location of this corner:

At position located from original bearing tree and official record notes, set a $2\frac{1}{2}$ inch brass cap on a 2 inch galvanized iron pipe 31 inches long and buried 27 inches in the ground with 4 inches projecting out of the ground with a surrounding rock mound and a 6 foot steel fence post alongside with a sign 54-4 attached. Buried original stone l foot North of brass cap monument.

New bearing trees:

A fir 10 ins diam bears N 56° W, 11.6 ft dist marked 1/4 S 12 BT. A fir 13 ins diam bears S 77° W, 26.8 ft dist marked 1/4 S 13 BT.

Each new bearing tree has a sign 54-3 nailed below a 6 inch band of red paint and a brass washer marked PLS 1639 nailed flush with BT blaze and a sign 54-4 nailed on opposite side of BT blaze.

The original bearing tree has a sign 54-3 and 54-4 attached and has a 6 inch band of red paint around tree.
