Found broken stone $18 \times 10 \times 6$ ins and rock mound. No chisle work identified.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set a $2\frac{1}{2}$ inch brass cap on a 2 inch galvanized iron pipe 31 inches long 26 inches in the ground and 5 inches projecting out of the ground with a surrounding rock mound and a 6 foot steel fence post alongside with a sign 54-4 attached.

A pine 8 ins diam bears N 53° W, 4.1 feet dist marked T 2 S R 37 E S 19 BT. A pine 8 ins diam bears S 58° W, 10.8 feet dist marked T 2 S R 37 E S 30 BT. A pine 6 ins diam bears N 61° E, 31.9 feet dist marked T 2 S R 37 E S 20 BT. A pine 12 ins diam bears S 78° E, 66.0 feet dist marked T 2 S R 37 W S 29 BT.

Each new bearing tree has a sign 54-3 nailed below a 6 inch band of red paint and a brass washer marked PLS 1639 nailed flush with BT blaze and a sign 54-4 nailed on opposite side of tree from BT blaze.
