

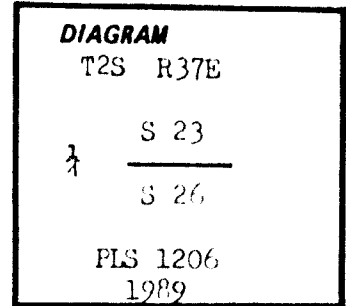
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Henry Meldrum surveyed the majority of the Township lines of Township 2 South, Range 37 East, W.M. under GLO contract no. 450, dated June 11, 1882.

Record states:

- $\frac{1}{4}$ S BT. A Pine 5 ins. diam. bears S. 3° E., 17 lks. dist., mkd.
- $\frac{1}{4}$ S BT. A Pine 5 ins. diam. bears N. 32° E., 19 lks. dist. mkd.



Description of corner evidence found:

No trace of the original corner post found.

Original bearing trees:

- A 6 in. dia. Lodgepole Pine, down and dead bears N. 32° E., 12.5 ft. dist., mkd.
- $\frac{1}{4}$ S BT on a open blaze.
- A roothole bears S. 3° E., 11.2 ft. dist.

Description of monument and accessories established to perpetuate the original location of this corner:

At the corner point as re-established from the remains of the two original bearing trees:

Set a 2 $\frac{1}{2}$ in. brass cap on a 1 in. iron pipe 26 ins. into the ground with a 2 $\frac{1}{4}$ in. dia. stone mound around it. Set a steel fence post 3 ft. dist. from said monument.

From which:

- A 9 in. dia. Douglas Fir bears S. 12° W., 4.4 ft. dist., mkd. $\frac{1}{4}$ S 26 BT.
- A 6 in. dia. Douglas Fir bears N. 80° E., 8.6 ft. dist., mkd. $\frac{1}{4}$ S 23 BT.
- A 9 in. dia. Douglas Fir bears N. 61 $\frac{1}{2}$ ° W., 11.5 ft. dist., mkd. $\frac{1}{4}$ S 23 BT.
- A 8 in. dia. Douglas Fir bears S. 59° E., 24.5 ft. dist., mkd. $\frac{1}{4}$ S 26 BT.

Attached USFS 54-9 and 54-3 signs to the bearing trees.
