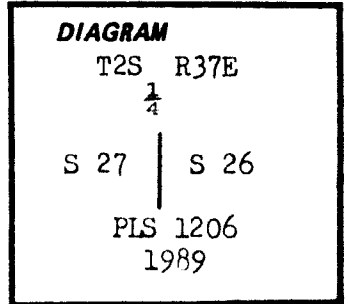


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Henry Meldurm surveyed the majority of the Township lines of Township 2 South, Range 37 East, W.M. under GLO contract no. 450, dated June 11, 1882.



Record states:

Set basalt stone, 24 x 16 x 5 in., stoney ground, piled stone around corner, marked $\frac{1}{4}$ on W. face.

From which:

- A Fir, 18 ins. dia. bears S. 37° E., 37 lks., mkd. $\frac{1}{4}$ S BT.
- A Pine, 30 ins. dia. bears N. 89° W., 73 lks., mkd. $\frac{1}{4}$ S BT.

Description of corner evidence found:

Found a basalt stone 17 x 12 x 6 ins. in a mound of stones with chiseled $\frac{1}{4}$ facing down.

Original bearing trees:

A 19 in. Ponderosa Pine stump (sawed and rotted) bears N. 89° W., 48.2 ft. dist. No scribe marks found.

A rotted and burned Douglas Fir stump, size indeterminate bears S. 37° E., 24.4 ft. dist. No scribe marks found.

Description of monument and accessories I established to perpetuate the original location of this corner:

In the place of the original found stone:

Set a 2 $\frac{1}{2}$ in. brass cap on a $\frac{1}{2}$ in. iron pipe projecting 24 ins. above the ground with a 48 in. dia. stone and earthen mound around it. Deposited the original corner stone 2 ft. North on the outside of the mound.

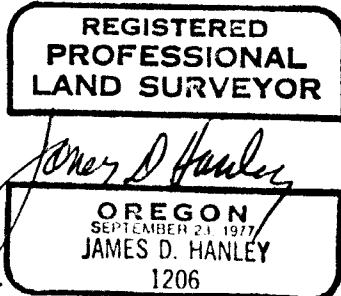
From which:

- A 11 in. dia. Ponderosa Pine bears N. 88° E., 18.0 ft. dist., mkd. $\frac{1}{4}$ S 26 BT.
- A 12 in. dia. Ponderosa Pine bears N. 47° W., 15.4 ft. dist., mkd. $\frac{1}{4}$ S 27 BT.
- A 13 in. dia. Ponderosa Pine bears S 57° E., 34.4 ft. dist., mkd. $\frac{1}{4}$ S 26 BT.
- A 11 in. dia. Ponderosa Pine bears S. 37° W., 71.6 ft. dist., mkd. $\frac{1}{4}$ S 27 BT.

Attached USFS 54-9 and 54-3 signs to all bearing trees.
