

#### HISTORY OF ORIGINAL CORNER ESTABLISHMENT:

Corner originally established by David P. Thompson, under GLO Contract No. 103, dated September 3, 1863. Surveyor General record states:

Set post for 1/4 sec. corner from which: A Pine 16 in. diam. bears N20°E, 77 lks. dist. A Pine 10 in. diam. bears N80°W, 252 lks. dist.

Corner remonumented by Duane Griffith in Union County Survey Number 58-77. Survey states that he set a 1" x 36" iron pipe with brass cap.





Found a 1 ½" iron pipe with 2 ½" brass cap, 4 inches below grade on North side of Igo Lane. Pipe is severely bent, however, the base of the pipe appears to be in it's original monumented position.

From the base of the monument position: A 5/8" iron pin, set by Minor Partition Number 1990-007 bears North 0°30' East, a distance of 30.04 feet, with yellow plastic cap marked BGA SURVEY MARKER.

# DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

I remove the disturbed iron pipe and at it's original position, I set a  $2\frac{1}{2}$ "X30" aluminum pipe with aluminum cap marked as shown below, 36" in the ground, from which:

#### NEW BEARING OBJECTS:

A 5/8"x30" iron pin bears South 42°56' East, a distance of 36.16 feet, with a 1  $\frac{1}{2}$ " aluminum cap marked UNION COUNTY SURVEYOR SE RP.

A 5/8"x30" iron pin bears South 20°58' West, a distance of 28.75 feet, with a 1 ½" aluminum cap marked UNION COUNTY SURVEYOR SW RP.


A 5/8"x30" iron pin bears North 72°35' West, a distance of 57.51 feet, with a 1  $\frac{1}{2}$ " aluminum cap marked UNION COUNTY SURVEYOR NW RP.


