
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

HISTORY OF ORIGINAL CORNER ESTABLISHED:

Corner established under GLO Contract No. 102, dated July 20th, 1863, executed by Timothy W. Davenport. Surveyor General Field Notes state:

Set post corner to secs 2, 3, 34, & 35, made mound of rock.



DESCRIPTION OF CORNER EVIDENCE FOUND:

Found a 4 ft. diameter embedded mound of rock approx.

10 ft. West of North/South running fence line. A BLM Location tag bears approx. 15 ft. Northwest, marked "approx. cor. by transit & chain, 9/74.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO MONUMENT THE ORIGINAL LOCATION OF THIS CORNER:

At center of 4 ft. mound of stone, I set a 2 1/2" x 30" aluminum pipe, 26" in the ground, with 3" aluminum cap marked as shown below, from which:

NEW BEARING OBJECTS:

A 5/8" x 15" iron pin bears North 51°20' East, a distance of 17.18 feet, with 1 $\frac{1}{2}$ " aluminum cap marked UNION COUNTY SURVEYOR NE RP

A 5/8" x 15" iron pin bears South 31°12' East, a distance of 25.54 feet, with 1 $\frac{1}{2}$ " aluminum cap marked UNION COUNTY SURVEYOR SE RP

A 5/8" x 15" iron pin bears South 26°41' West, a distance of 16.59 feet, with 1 ½"

aluminum cap marked UNION COUNTY SURVEYOR SW RP A 5/8" x 15" iron pin bears North 39°07' West, a distance of 13.11 feet, with 1 ½" aluminum cap marked UNION COUNTY SURVEYOR NW RP

Set steel fence post approx. 2 ft. West


