

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

HISTORY OF ORIGINAL CORNER ESTABLISHED:

Corner originally established under GLO contract number 103 executed by Daniel P. Thompson, dated September 3rd 1863. Surveyor General field notes state:

Set qr sec post from which
A tamarack 24" diam bears South 85° East, 27 lks dist
A tamarack 8" diam bears North 70° West, 30 lks dist

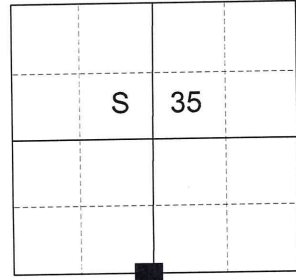
DESCRIPTION OF CORNER EVIDENCE FOUND:

Found 3 ft. diam. mound of stone with fence post in center with BLM tag stating "probable corner is here", from which:

An approx. 20" stump bears South 83° East, a dist. of 20.20 ft., burnt and standing approx. 6 ft. tall.

A severely decayed stump bears North 69° West, a dist. of 21.50 ft., standing approx. 2 ft. tall with partial scribes visible.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO MONUMENT THE ORIGINAL LOCATION OF THIS CORNER:

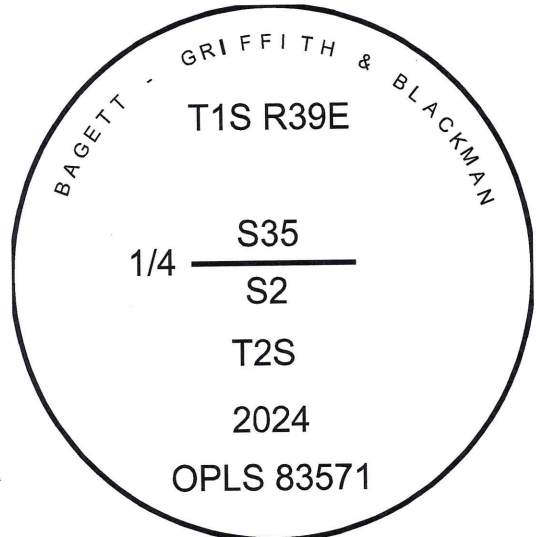
At the center of the found mound of stone, I set a 2 1/2" x 30" aluminum pipe, 29" in the ground, with 3" aluminum cap marked as shown and in a 3 ft. mound of stone, from which:

NEW BEARING OBJECTS:

A 6" Ponderosa Pine bears North 65° East, a dist. of 14.70 ft., marked 1/4 S35 BT.
A 9" Douglas Fir bears South 47° East, a dist. of 28.75 ft., marked 1/4 S2 BT.
A 4' x 4' x 3' boulder bears South 47° West, a dist. of 46.30 ft., marked X BO on East face.
A 9" Ponderosa Pine bears North 78° West, a dist. of 15.40 ft., marked 1/4 S35 BT

Set steel fencepost 0.5 ft. West

I hereby certify that the corner was monumented on July 19th, 2024.

I use a tape and compass in the establishment of the new bearing objects. 14° East was used for declination and measured to a brass washer labeled "OPLS 83571" in the BT blaze at the base of the tree. Distances are to a 60D nail in the right side of the base of the center of the tree.
