
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

At position determined by survey, I set a 5/8"x30" iron pin with 2 1/2" aluminum cap, marked as shown below, 36" in the ground, from which:



- A 5/8" x 30" iron pin bears South 29° 40' West, a distance of 40.20 feet, with 1 ½" aluminum cap marked BGB SURVEY MARKER SW RP
- A 5/8" x 30" iron pin bears North 49° 38' West, a distance of 21.66 feet, with 1 2" aluminum cap marked BGB SURVEY MARKER NW RP
