## History of original corner establishment:

A fir 9 ins. diam., bears S42°E, 5 lks., dist. mkd T2SS2 BT. A fir, 12 ins. diam. bears., S52°W, 9 lks. diat. mkd. S3 BT. A fir, 9 ins. diam., bears N70°W., 3 lks. diat. mkd. R40ES34 BT"
