
DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED



A 5/8" x 15" iron pin bears South 26°56' East, a distance of 10.91 feet, with 1 ½" aluminum cap marked BGB SURVEY MARKER SE RP. A 5/8" x 15" iron pin bears South 39°59' West, a distance of 9.73 feet, with 1 ½" aluminum cap marked BGB SURVEY MARKER SW RP. A 5/8" x 15" iron pin bears North 42°48' West, a distance of 11.69 feet, with 1 ½" aluminum cap marked BGB SURVEY MARKER NW RP.


