Cor marked 1/4 S on W face, from which: A fir 15 ins diam bears  $S69^{\circ}E$ , 24 lks dist marked 1/4 S BT. A fir 10 ins diam bears  $N67^{\circ}W$ , 28 lks dist marked 1/4 S BT.

### Description of corner evidence found:

None. Corner reestablished by proportionate measurement from survey control.

Corner not found in area of old wildfire and west edge of recent logging. Unable to find any standing trees older than 90 years as determined by increment bore and trees are predominantly lodgepole pine and western larch.

## Description of monument and accessories I established to perpetuate the original location of this corner:

At position midway between adjacent section corners North and South ...

Set a 2" x 30" aluminum pipe with  $2\frac{1}{2}$ " aluminum cap 24" in ground & projecting 6" out of ground with surrounding earth mound & placed 6' steel fence post alongside with sign 54-9 attached. Cap marked as shown in corner diagram. No stones available for mound.

New bearing trees established: White fir 15" dia brs  $S61_{0}^{10}E$ , 55.9' dist mkd 1/4 S15 BT. White fir 17" dia brs  $S81_{0}^{0}W$ , 60.3' dist mkd 1/4 S16 BT.

New bearing trees have a brass washer marked PLS 1639 nailed flush to face of blaze. Attached signs 54-3 & 54-9 & painted face of blaze & a 6' band of red around each bearing tree.

Compass declination 19° East.


