Corner found and accepted by Henry Meldrum in GLO contract number 450, dated June 11, 1882. Surveyor General field notes state:

The corner of secs 16, 17, 20 and 21, which is a post 4 ft. long, 4 in. square marked T2S S16 on NE, R40E S17 on NW, S20 on SW and S21 on Se with 3 notches on S and 4 on E edges. The pits and mound of earth having been mostly destroyed I replace same with stone mound around post.

DESCRIPTION OF CORNER EVIDENCE FOUND:

None. A fence corner fits very harmoniously with a proportionate position between the Northeast corner of Section 17 and the quarter corner between Sections 20 and 21. Fences bear North, East and West. A stone wall extends to the West.

A 5/8" x 15" iron pin bears South 85°57' East, a distance of 25.24 feet, with 1 $\frac{1}{2}$ " aluminum cap marked BGB SURVEY MARKER E RP.

A $5/8" \times 15"$ iron pin bears North 3°56' West, a distance of 21.26 feet, with 1 $\frac{1}{2}"$ aluminum cap marked BGB SURVEY MARKER N RP.

A $5/8" \times 15"$ iron pin bears South $88^\circ27'$ West, a distance of 26.58 feet, with 1 ½" aluminum cap marked BGB SURVEY MARKER W RP.

A rock outcrop, exposed portion being approx. 2'x3', marked 'X BO' bears North 28°52' East, a distance of 13.83 feet.

Corner falls along Northeast edge of fence corner. I hereby certify that the corner was monumented April 20, 2016.




