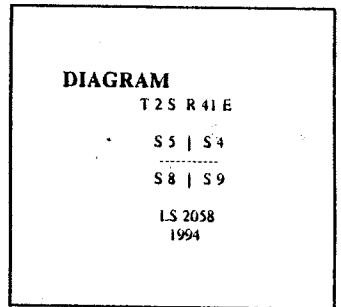

A TAMARACK, 36 INS. DIAM., BEARS S.71½°W., 210 LKS. DIST. MKD. T2S R41E S8 BT



NO TREES IN LIMITS FOR SECS. 5 AND 9, THEREFOR BUILT MOUND OF STONE 3 FT BASE 2 FT. HIGH 10 LKS W. OF COR. POINT SO THIS COR IS IN A ROCKY DEPOSIT - I WAS UNABLE TO SET IT IN THE GROUND, I THEREFOR BUILT A MOUND OF STONE 2½ FT. BASE 18 INCHES HIGH AROUND COR.

Description of monument and accessories I established to perpetuate the original location of this corner:

SET A 3/4" DRILL HOLE ON THE TOP OF A STONE, WITH A 3/4" ALUMINUM CAPPED MONUMENT 30" ABOVE THE GROUND, WITH MOUND OF STONE TO CAP, CAP MARKED PER DIAGRAM, FROM WHICH:

- A DRILL HOLE, ½" IN DIAM. IN A 40"X27"X40" STONE, BEARS N.35°34'W., 48.18'
- A DRILL HOLE, ½" IN DIAM. IN A 54"X51"X29" STONE, BEARS N.36°03'E., 47.71'
- A DRILL HOLE, ½" IN DIAM. IN A 46"X32"X12" STONE, BEARS S.57°15'E., 51.43'
- A DRILL HOLE, ½" IN DIAM. IN A 48"X36"X48" STONE, BEARS S.21°50'E., 44.87'
