## History of original corner establishments

Corner established by Rufus S. Moore in 1882 Under GLO Contract No. 437

Set a post 4" square from which:

A Fir 10" in Diam. S 33°W 45 lks. A Tamarack 12" in Diam. S 52°E 26 lks. A Tamarack 20" in Diam. N 81°E 37 lks. A Tamarack 20" in Dian. N 60°W 26 lks.

## Description of corner evidence found:

Found original NE B.T. a sawn tamarack stump 20" diameter with axe marks facing S.W. long butt lying alongside has partly healed blaze with scribing "I 4N R 39E", visible bears N 81 E, 24.04 ft. from corner. Using this bearing and distance I carefully dug a 3' diameter hole scraping a few inches at a time. At 8" depth I found the charred remains of the original post perfectly square about 3%" to 4" continuing to a depth of about 18". At this point I set the new corner monument.

## Description of monument and accessories I established to perpetuate the original location of this corner

For this corner I set an aluminum cap 2½" Diam. on a 30" aluminum pipe 26" in the gound. stamped

I scribed 4 (four) new trees

A 13" Tamarack bears N 20°E 32.29 ft. Marked T 4 N R 39E S 34 B.T.

A 9½" Tamarack bears N 580W 30.50 ft. Marked T 4N R 39E S 33 B.T.

A 9" Tamarack bears S 80°W 44.00 ft. Marked T 3N R 39E S 4 B.T.

A 10" Fir bears S 71°E 33.60 ft. Marked T 3N'R 39E S 3 B.T.

All trees have painted red blazes and 6" red stripes below B.T. tag's. All trees have signs 54-4 & 54-3 also brass washer "PLS 933" on lower blaze. Set steel post 5 feet North with signs 54-9 & 54-4.

I used a steel tape and magnetic compass with 20° variation and measured a horizontal distance to the center of the B.T.'s
