History of original corner establishment:

Surveyor General's notes state: "Set Fir post 4 ft. long, 4 ins. square 24 ins. in the ground for corner to secs. 1, 2, 11, and 12. From which a pine 20 ins. in diam. bears N54°E, 15 lks. dist. marked T3NR39ES1 BT. A pine 36 ins. diam. bears S20°E, 20 lks. dist. marked T3NR39ES12 BT. A Tamarack 12 ins. diam. bears S15°W, 14 lks. dist. marked T3NR39ES11 BT. A Fir 15 ins. diam. bears N38°W 9 lks. dist. marked T3NR39ES2 BT.

Description of corner evidence found:

Found no trace of wood post. Found 36" pine stump with BT on lower blaze. Measured S54°W, 9.9 ft. Measured S20°E, 13 ft. to a stump hole of a pushed over stump with full scribe. Found no trace of other BTs.

Corner falls about 12 ft. Northeast of a fence corner.

Description of monument and accessories I established to perpetuate the original location of this corner:

T3N R39E At the above described point set 2 1/2" X 30" Galvanized pipe S 2 | S 1 and brass cap marked: S11 | S12 Set pipe 24" in the ground and mound of stone around to cap. From which by magnetic declination of N20°E: A 15" Fir bears
