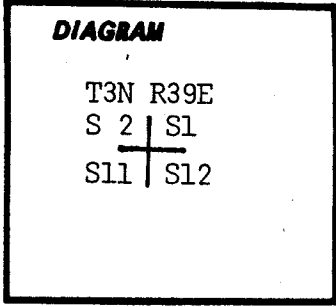


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Index File No. E-21

History of original corner establishment:

Corner established by F. W. Campbell under G. L. O. contract No. 498 in may, 1884. Surveyor General's notes state: "Set Fir post 4 ft. long, 4 ins. square 24 ins. in the ground for corner to secs. 1, 2, 11, and 12. From which a pine 20 ins. in diam. bears N54°E, 15 lks. dist. marked T3NR39ES1 BT. A pine 36 ins. diam. bears S20°E, 20 lks. dist. marked T3NR39ES12 BT. A Tamarack 12 ins. diam. bears S15°W, 14 lks. dist. marked T3NR39ES11 BT. A Fir 15 ins. diam. bears N38°W 9 lks. dist. marked T3NR39ES2 BT.



Description of corner evidence found:

Found no trace of wood post. Found 36" pine stump with BT on lower blaze. Measured S54°W, 9.9 ft. Measured S20°E, 13 ft. to a stump hole of a pushed over stump with full scribe. Found no trace of other BTs.

Corner falls about 12 ft. Northeast of a fence corner.

Description of monument and accessories | established to perpetuate the original location of this corner:

At the above described point set 2 1/2" X 30" Galvanized pipe and brass cap marked:
Set pipe 24" in the ground and mound of stone around to cap. From which by magnetic declination of N20°E: A 15" Fir bears N18°E, 74.7 ft. scribed T3NR39ES1 BT. A 10" Tamarac bears S47°E, 54.1 ft. scribed T3NR39ES12 BT. A 10" Fir bears S41°W, 10.3 ft. scribed T3NR39ES11 BT. A 20" Pine bears N71°W, 34.8 ft. scribed T3NR39ES2 BT. Painted blazes red and 6" red band around. Placed 54-3s and brass washers stamped PLS 1051 on BTs. Placed 54-4 on a steel fence post 5' East of the corner.
