History of original corner establishment:

Original survey by F.W. Campbell, 1884, states:

Set a Pine post 3 ft. long, 3 ins. square, 24 ins. in the ground for 1/4 Sec. corner marked 1/4 S. on West face, from which: A Pine 12 ins. diam. bears S74°E 58 lks. dist. marked "1/4 S BT"

A Pine 27" diam. bears S30°W 113 lks. dist. marked "1/4 S BT"

Description of corner evidence found: No physical evidence of the original corner was found.

Description of monument and accessories I established to perpetuate the original location of this corner:

Original County Road Petition No. 667 dated 1916 for a road now known as Cabin Creek County Road No. 140 states in its legal description: "Beginning at the center post on the West side of Section 36, T3N, R39E, W.M., where said section line intersects with the present County Road, thence due East to center of said Section 36,....

At the corner site, we find the following: The existing Cabin Creek County Road running Easterly within a well-defined and fenced right-of-way,

The visible ditchlines and roadbed of an abandoned roadway running Southwest through a wooded area.

And a well-defined fenceline running northerly from the corner site.

In our opinion, the original location of the 1/4 35/36 T3N, R39E has been perpetuated and can be restored by reference to the existing roadways and evidence of land occupation in the area. We therefore establish the 1/4 corner of Sec. 35 and 36, T3N, R39E in the center of the fenced right-of-way of Cabin Creek County Road at its intersection with the Southerly extension of the line from the NW corner of Sec. 36 through the existing fence corner located along the Northerly fence line as depicted on the Map of Survey being filed concurrently with this record.

At the corner point thus determined, we set a 40 penny spike as a temporary monument due to pending reconstruction of the roadway. We establish the following bearing objects: A 5/8"x30" Iron Rod with yellow

HISTORY OF ORIGINAL CORNER ESTABLISHED:

Corner originally established by F.W. Campbell under GLO contract 498, dated March 10, 1884. Surveyor General field notes state:

Set a pine post 3 ft. long 3 ins. square, 24 ins. in the ground for 1/4 Sec. corner marked 1/4 S on West face, from which: A pine 12 in. diam. bears S74°E, 58 lks. dist. marked 1/4 S BT. A pine 27 ins. diam. bears S30°W, 113 lks. dist. marked 1/4 S BT.

County Road Petition 667 utilizes this corner. Legal description states "Beginning at the center post on the West side of Section 36, T3N, R39E, WM, where said section line intersects with the present County Road...". Acceptance of wood stake as 1/4 corner by County engineer's office is shown on road plat dated Aug. 19, 1916.

In Survey 14-85, Gary Langlitz places the corner by retracement of the county road, and existing lines of possession. Union County Monumentation record 33-85R states:

We therefore establish the 1/4 corner of Section 35 and 36 in the center of the fenced right-of-way of Cabin Creek county Road at its intersection with the Southerly extension of the line from the NW corner of Sec. 36 through the existing fence corner located along the Northerly fence line. At the corner point thus determined, we set a 40 penny spike as a temporary monument due to pending reconstruction of the roadway. We establish the following bearing objects:

A 5/8" x 30" iron rod with yellow plastic cap marked "AP&A" attached, set along an existing E-W fence line, bears N64°W., 64.92 feet. A 5/8" x 30" iron rod with yellow plastic cap marked "AP&A" attached, set along an existing E-W fence line, bears N41°E., 37.78 feet.

DESCRIPTION OF CORNER EVIDENCE FOUND:

Found references set by Survey Number 14-85, at a point established by distance intersection from reference pins: A 5/8" x 30" iron rod bears North 64°36'39" West, a distance of 64.92 feet, with yellow plastic cap marked AP&A in East/West fence line. A 5/8" x 30" iron rod bears North 38°14'52" East, a distance of 37.78 feet, with yellow plastic cap marked AP&A in East/West fence line.




NEW BEARING OBJECTS:




