A fir 27ins. diam. bears S82°W., 159 lks. dist. marked
T3NR40ES1 BT. A pine 28 ins. diam. bears N70°W., 100 lks. dist. marked
T4NR40ES36 BT."

## Description of corner evidence found:

Found no trace of record stone. Found down and rotten pine with full scribe for section 36. Measured S70°E., 66.0 ft. from where a rotten pine stump bears S12°E., 49.1 ft. Found no trace of NE BT. Old fir pieces bears S80°W., about 105 ft.

## Description of monument and accessories I established to perpetuate the original location of this corner:

At center of measured point, set 2 1/2" x 30" galvanized pipe and brass cap marked: Set pipe 18" in the ground and mound of stone around to cap.

From which by magnetic declination of N20°E:
A 11" Fir bears N53°W., 21.6 ft. scribed T4NR40E S36 BT.
A 15" Fir bears S63°W., 132.7 ft. scribed T3NR40ES1 BT.
Painted blazes red and 6" red band around. Placed 54-3s, 54-4s and brass washers stamped PLS 1051 on BTs. Placed 54-4 on a steel fence post 5' west of the corner.
