Set a basalt stone 12x12x8 ins. 8 ins in the ground. for cor. to Secs 26, 27, 34 & 35, marked with 1 notch on S and 2 notches on E edges, from which:

A tamarack 18 ins. in diam. bears N11°E., 21 lks dist. marked T3N R40E S26BT.

A fir 10 ins. in diam. bears S20E., 36 lks dist. marked T3N R40E S35 BT.

A fir 10 ins. in diam bears S5W, 40 lks dist. marked T3N R40E S34 BT.

A fir 12 ins. in diam. bears N13W. 15 lks dist. marked T3N R40E S27 BT.

DESCRIPTION OF CORNER EVIDENCE FOUND:

Found remains of a decaying tamarack stump, approx. 23" in diameter. Scribes visible on decaying downed portion. At record bearing and distance from this tree, I find a volcanic stone 12"x12"x8", with no chisel marks evident. Stone is of a type that is dissimilar from surrounding stone.

A 12" Douglas Fir bears North 17° East, a distance of 23.15 feet, marked T3N R40E S26 BT


A 13" Douglas Fit bears South 87° East, a distance of 48.15 feet, marked T3N R40E S35 BT
