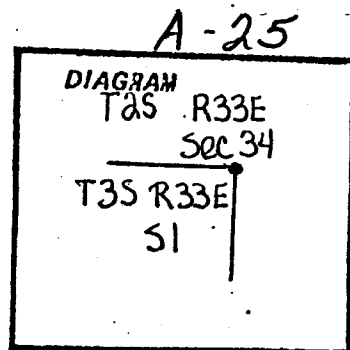


History of original corner establishment:

The exterior lines of Township 3S, Range 33E were originally established by Rufus L. Moore under Contract No. 451 dated June 12, 1882. The original notes state that at the corner a 5' long by 4" square post was set 24" in the ground from which: A 6" tamarack bears N27°E 42 LK (27.7 ft) marked T2S R34E BT A 15" fir bears N23°W 44 LK (29.0 ft) marked T2S R33E S36 BT A 9" fir bears S28°W 25 LK (16.5 ft) marked T3S R33E S1 BT A 11" pine bears S45°E 63 LK (41.6 ft) marked T3S R34E BT

Note: Township 2S Range 33E was later surveyed resulting in the section configuration shown.



No record of subsequent re-monumentation found in County records.

Description of corner evidence found:

Found remains of rotted post record distance from original BT's.  
A 21" ponderosa pine with scribing visible bears S45°E 41.6 ft to face of blaze 42.2 ft to center of tree.  
The remains of a rotted tree bears N27°E 27.7 ft approximately.  
The rotted remains of a BT with scribing visible bears N23°W 28.9 ft approximately

Description of monument and accessories established to perpetuate the original location of this corner:

At the corner position a 2 inch by 30 inch iron pipe, with brass cap marked as shown, was set 24 inches in ground and surrounded with a mound of stones.

Set a steel fence post West and South of corner on Township and Range lines with signs 54-4 and 54-2 attached.

Established 2 new BT's : A 7 1/2" fir bears S19°W 46.9 ft, scribed T3S R33E S1 BT.

A 9" tamarack bears S65 1/2°W 62.5 ft. scribed T3S R33E S1 BT.

New BT's have a lower blaze scribed BT with brass washer stamped PLS 1106 nailed flush.

Attached signs 54-3 and 54-4 and painted red ring around all BT's.

Used steel tape and magnetic compass with 19 1/2° east variation. Measured to center of BT's.

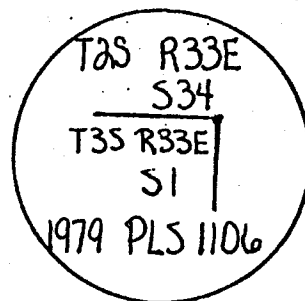
