History of original corner establishment:

Corner was originally established by Rufus S. Moore under GLO contract No. 451. Corner was recovered by L. Wilkes survey group No. 38, in October, 1917. Surveyors General's notes state: "Set an iron post, 3 ft, long, 2 ins. diam. 24 ins. in the ground., for cor. of secs. 1, 2, 35 and 36 with brass cap marked:

from which: A pine, 29 ins. diam., bears N31°E., 38 lks. dist. marked T2SE34ES36 BT (Old B.T.). A pine, 20 ins. diam. bears S79°E., 38 lks. diat, marked T3SR34E S1 BT (Old B.T.). A pine, 16 ins. diam. bears S78°30'W., 27 lk.s dist. marked T3SR34ES2 BT (Old B.T.). A pine, 30 ins. diam. bears N80°W, 190 lks. dist.

marked T2SR34ES35 BT (Old B.T.).

Description of Corner Evidence Found:

Found 2" iron pipe and brass cap projecting 14" above the ground. Old wood post on mound. From which by magnetic declination of N20°E: A 30" pine bears N48°E, 25.7 ft. with visible scribing. A 24" pine bears S77°E, 26.4 ft. with visible scribing. An 18" pine stump bears S79°W, 17.1 ft. visible BT. A 30" dead pine bears N79°W, 126.8 ft. with visible scribing.

Description of monument and accessories I established to perpetuate the original location of this corner:

Built mound of stone around to cap. From which I add: A 16" pine bears S70°W, 61.1 ft. scribed T3SR34ES2 BT. A 9" pine bears N64°W, 50.3 ft. scribed T2SR34ES 35 BT. Painted blazes red and 6" red band around. Placed 54-3s, 54-4s and brass washers stamped PLS 1051 on BTs. Placed 54-2 and 54-4 on steel fence post 5' east and 54-2 on steel fence post 5' north of the corner.
