## History of original corner establishment:

Corner was originally established by Rufus S. Moore under GLO contract No. 451 during November, 1882. Surveyor General's notes state: "Set a basalt stone 18x8x7 ins., 12 ins. in the ground for cor. to cecs. 2,3, 10, and 11. marked with 5 notches on S and 2 notches on E edges. From which: A fir 34 ins. diam. bears N30°E, 20 lks. dist. marked T3SR34ES2 BT. A fir 42 ins. diam. bears N48°W, 57 lks. dist. marked T3SR34ES3 BT. A fir 34 ins. dia. bears S18°W, 43 lks. dist marked. T3SR34ES10 BT. A fir 14 ins. diam. bears S 48°E, 33 lks. dist marked T3SR34ES11 BT."

## Description of corner evidence found:

Found 19x9x8 inch ctone loosely set in ground with 5 and 2 notches. From which: A 36" rotten stump bears N25°E, 14.2 ft. scribed. A down and rotten 16" fir bears S48°E, 22.0 ft. with full scribe. A rotten lig bears approximately S70°W, 30 ft. and a 42" rotten stump bears N49°W, 39.7 ft.

Description of monument and accessories I established to perpetuate the original location of this corner:

At center of the above stone set 2 1/2" X 30 " galvanized S10 S11 pipe and brass cap marked: Set pipe 24" in the ground of stone around to cap. Placed marked stone alongside. 1980 Prom which by magnetic declination of N20°E: A 12" fir bears N69°E, 25.4 ft. scribed T3SR34ES2 BT. A 12" fir bears S40°E, 30.4 ft. scribed T3SR34ES11 BT. A 20" pine bears S 82°W, 23.6 ft. scribed T3SR34ES10 BT. A 10" fir bears N63°W, 24.4 ft. scribed T3SR34ES3 BT. Painted blazes red and 6" red band around. placed 54-3s, 54-4s and brass washers stamped PLS 1051 on BT. Placed 54-4 on steel fence post 5' north of the corner.
