History of original corner establishment:

Corner was originally established by Rufus S. Moore under GLO contract No. 451, during November, 1882. Surveyor General's notes state: "Set a basalt stone 18x14x8, 12 ins. in the ground for cor. to secs. 11, 12, 13 and 14 marked with 4 notches on S and 1 notch on E edges. From which: A pine 11 ins. diam bears N43°E, 54 lks. dist. marked T3SS12 BT. A fir 10 ins. diam. bears N33PW, 79 lks. dist. marked R34ES11 BT. A pine 15 ins. diam. bears S55°W, 16 lks. dist. marked S14 BT. A pine 4 ins. diam. bears S42°E, 72 lks. dist. marked S13 BT."

Description of corner evidence found:

Found no trace of record stone. Found 22" pine bearing N45°E, 36.0 ft. partially grown over blazes and visible scribing. A 34" pine with burnt NW face bears S41°E, 51.0 ft. A 24" burnt pine snag bears S74°W, 11.5 ft. A 28" fir with grown ober blazes bears N33°W, 52.2 ft.

Corner falls near T fence corner.

Description of monument and accessories I established to perpetuate the original location of this corner:

At the center of above point set 2 1/2" X 30" galvanized pipe and brass cap marked: Set pipe 22" in the ground and mound of stone around to cap.

From which by magnetic declination of N20°E: A 13" fir bears S26°E, 54.2 ft. scribed T3SR34E S13 BT. A 14" fir bears S15°W, 26.3 ft. scribed T3SR34ES14 BT. Painted blazes red and 6" red band around. Placed 54-3s and 54-4s on old and new BTs. Placed brass washers stamped PLS 1051 on new BTs. Placed 54-2 and 54-4 on steel fence post 5' east and 54-2 on steel

fence post 5' south of the corner.
