History of original corner establishment:

Corner was originally established by Rufus S. Moore under GLO contract No. 451 during November, 1882. Surveyor General's notes state: "Set a post 4 ft. long, 4 ins. sq. 24 ins. in ground for cor to secs. 13, 14, 23 and 24- marked.....From which: A fir 34 ins. diam. bears N72°E, 81 lks. dist. marked T3SR34ES13 BT. A pine 32 ins. diam. bears N47°W, 60 lks. dist. marked T3SR34ES14 BT. A pine 28 ins. diam. bears S18°W, 84 lks. dist. marked T3S34RS23 BT. A pine 22 ins. diam. bears S74°E, 62 lks. dist. marked T3SR34ES24 BT."

Description of corner evidence found:

Near old mound of stone found 32" fir stump bearing N73°E, 56.0 ft., a 26" pine bearing S74°E, 43.0 ft. visible scribing. An 18" rotten pine stump bearing S18°W, 56.0 ft., a 24" rotten pine srump bearin N45°W, 39.0 ft.

Corner falls near N-S fence.

Description of monument and accessories I established to perpetuate the original location of this corner:

At the above point set 2 1/2" X 30" galvanized pipe and brass cap marked: Set pipe 24" in the ground and mound of stone around to cap.

From which by magnetic declination of N20°E;

A 9" pine bears N60°E, 18.6 ft. scribed T3SR34ES13 BT. A 9" fir bears S35°W, 13.0 ft. scribed T3SR34ES23 BT. An 18" pine bears N15°W, 40.5 ft. scribed T3SR34ES14 BT. Placed 54-3s on old stumps. Old BT tagged. Painted blazes red and 6" red band around. Placed 54-3s, 54-4s and brass washers stamped PlS on BTs. Placed 54-2 and 54-4 on steel fence post 5' north of the corner.
