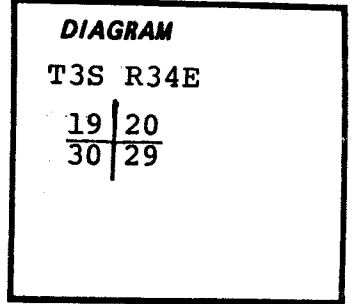


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Index File No. R-05

History of original corner establishment:

In 1882, under GLO Contract No. 451, Rufus S. Moore set a stone 28x10x8, from which a 34" Pine bears N52°W, 158 lks.; a 40" Pine bears N17°E, 200 lks.; a 34" Pine bears S48°E, 186 lks.; and a 15" Pine bears S13°W, 118 lks.



Description of corner evidence found:

Found original stone, 28x10x8.

Bearing trees found:

- A 31 1/2" P. Pine bears N52°W, 106.0 ft., blaze healed.
- A 37 1/2" dead standing P. Pine bears N17°E, 136.0 ft., scribing visible "T3S R34E S20 BT".
- A 19"x12" double standing dead P. Pine bears S48°E, 124.6 ft., scribing visible but faint.
- A 13" dead standing P. Pine bears S63°W, 76.8 ft., scribing visible "T3S R34E S30 BT".

Description of monument and accessories established to perpetuate the original location of this corner:

Set 2 1/2"x30" aluminum capped aluminum pipe rising 16" in mound with original stone in mound along north side. Cap stamped:

- A 10" P. Pine bears N31 1/2°E, 127.3 ft., scribed T3S R34E S20 BT. T3S R34E
- An 11" P. Pine bears S12°E, 111.3 ft., scribed T3S R34E S29 BT.  $\frac{S19}{S30} \mid \frac{S20}{S29}$
- An 8 1/2" P. Pine bears S40°W, 102.7 ft., scribed T3S R34E S30 BT. RLS 1848

Painted blazes and attached signs as per Standard Specifications for Cadastral Surveys, USFS Region 6, March 1982. Set metal post 4 ft. north of corner.  
Compass Declination: 19 1/2°E Witness: J. Sutton

From 21, 2100-140 south 1/2 mi. to the gate. walk down meadow creek 1/2 mi. to where it turns south. Corner is east up the hill 300 ft. in the middle of a clearing.
