## History of original corner establishment:

Corne was originally established by Rufus S. Moore under GLO contract No. 451 during November, 1882. Surveyor General's notes state: "Set post 4 1/2 ft. long 4 ins sq. 2 ft. in the ground with mound of rock around 3 1/2 ft. at base, 18 ins. high (in open pine timber on summit of small fidge terminating west about 10.00 chs.) For cor. to sec. 7, 12, 13, and 18. A pine 16 ins. diam. bears N28°E, 35 lks. diat marked T3SR35ES7 BT. A pine 13 ins. diam bears N35°W, 63 lks. dist marked. T3SR34ES12 BT. A pine 24 ins. diam. bears S85°W, 61 lks. dist. marked T3SR34ES13 BT."

## Description of corner evidence found:

Found old mound of stone and part of old rotten post from which a 26" pine bears N31°E, 22.8 ft. with visible scribing. A 34" pine bears S 84°W, 40.6 ft. with grown over blazes. A 28" pine bears N35°W. 42.0 ft. with partially grown over blazes.

## Description of monument and accessories I established to perpetuate the original location of this corner:

At center of stone mound set 2 1/2" X 30" galvanized pipe and brass cap marked: Set pipe 20" in the ground and mpund of stone around to cap.

From which by magnetic declination of N20°E:

A 12" pine bears S87°E, 76.3 ft. scribed T3SR35ES18 BT. Painted blazes red and 6" red band around. Placed 54-3, 54-4 and brass washers stamped PLS 1051 on BTs. Placed 54-2 and 54-4 on steel fence post 5' north and 54-2 on steel fence post 5' east of the corner. Old BTs are signed.
