
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: Corner established in 1873 by J. Hurlburt, under General Land Office Contract No. 201.
Surveyor General's records state:

Set Pine post -4-ft. long 3 in. thick 2 ft. in ground for 1/4 Sec. Cor.

Pine 12 ins. dia. N72°W, 37 lks. Pine 15 ins. dia. S39°E, 110 lks.



Description of corner evidence found:

Form

At assumed corner location could find no trace of original corner post. Found 18 inch P. Pine, bearing S39°E, 110 lks. with Visible scribing in open blaze. Found 25 inch P. Pine bearing N72°W, 37 lks. with healed blaze.

Description of monument and accessories l'established to perpetuate the

original location of this corner: Used recorded distances from faces of both found BT's to reestablish the original corner position, at which point set $2\frac{1}{2}$ "x30" galvanized pipe with brass cap stamped:

Set pipe 22" in the ground with mound of stone to cap.

USE THE ORIGINAL BEARING TREES:
A P. Pine 18 inches in dia. bears S45°E, 72.6 feet with visible scribing in open blaze. (Dying)
A P. Pine 25 inches in dia. bears N64°W, 24.45 feet with healed blaze. Replaces Southeast dying BT.

Attached 54-3 and 54-4 signs to both BT's. Painted blazes and 6" band around both BT's orange. Attached 54-4 sign to metal fence post 5 ft. North of corner.
