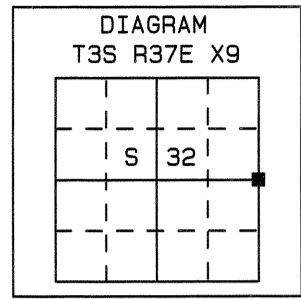


**CERTIFIED RECORD OF LAND CORNER MONUMENTATION**

**HISTORY OF ORIGINAL CORNER ESTABLISHMENT:**

The corner was originally established by William H. Odell under GLO contract No. 120 dated May 27, 1867. The Surveyor General Record states:

Set 1/4 Sec. post cor. From which  
 A pine 20 in dia bears S20°E 6 lks.  
 A pine 8 in dia bears N12°W 70 lks.



I found no subsequent record of monumentation in the Union County survey records.

**DESCRIPTION OF CORNER EVIDENCE FOUND:**

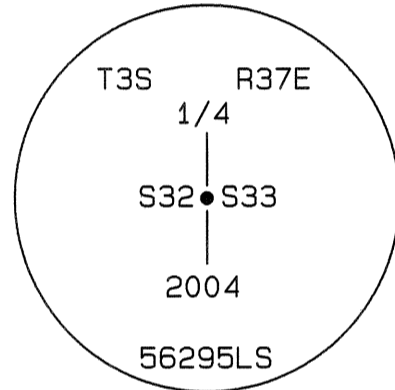
A fence corner lying immediately West of a north south road. There were fences running North and East from this point. There were remains of pine stumps in the road fill near this point. I held this point as the best available evidence because it is near the record bearing and agrees with Odell's typical distance north of the section corner to the South. A location poster on a pine tree just west of this corner bears the date 1951 and states that the section corner is 43 chains north of this point.

**DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:**

At the fence corner I set a 2 1/4" Brass Cap on a 1 3/8" x 30" galvanized iron pipe 30" in the ground. I stamped the cap as shown below.

I marked four bearing trees. Each bearing tree has a 1 1/2" brass washer fastened between the letters B and T with a 2" PK nail. The washer is stamped WTS and 56295 LS. Measurements were taken to the dent in the head of the nail with a Trimble 5601 electronic total station. Bearings are based on the survey control for County Survey No. 032-2004.

- A 9" Ponderosa Pine bears N71°20'11"W, 56.20', scribed 1/4 S32 BT.
- A 19" Douglas Fir bears N59°03'34"E, 34.59', scribed 1/4 S33 BT.
- A 15" Ponderosa Pine bears S60°29'30"E, 41.44', scribed 1/4 S33 BT.
- A 15" Ponderosa Pine bears S47°09'29"W, 9.17', scribed 1/4 S32 BT.
