

## CERTIFIED RECORD OF LAND CORNER MONUMENTATION

HISTORY OF ORIGINAL CORNER ESTABLISHMENT:

A monument reporting to be this corner was set by improper methods in 1941 by Morgan. His record reads:

Set 2"  $\times$  2" post. 5" Tree pine bears N50  $^{\circ}$ W 10.5'.



I found no subsequent record of monumentation in the Union County survey records.


DESCRIPTION OF CORNER EVIDENCE FOUND: None.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the proper position computed per the 1973 Manual of instructions I set 3" domed brass cap cemented in a drill hole in the bedrock 3" below the surface. The cap was stamped as shown below.


I marked two bearing trees. Each bearing tree has a copper nail with a 1 1/8" head stamped WTS and 56295LS driven between the letters B & T. Measurements were taken to the dent in the head of the nail with a Trimble 5601 electronic total station. Bearings are based on the survey control for County Survey No. 032-2004.

An 13" Ponderosa Pine bears S35°47'20"W, 52.34', scribed SW 1/16 S32 BT.
An 12" Ponderosa Pine bears S57°18'57"E, 34.52', scribed SW 1/16 S32 BT.
