
## CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner originally established by David T. Thompson under GLO contract Number 103, dated September 3, 1863. Surveyor General record states:

Set post for cor to secs 14, 15, 22 & 23 in mound of earth with charred stake, pits, and trenches as per instructions.

Survey 8-71, 15-71, 37-71, 63-71, 89-71, 7-72, 1-74, 43-77, 13-78, 21-78, and 28-80 all call found monument of record or found RR spike at corner position.



No record of subsequent monumentation found in Union County survey records Description of corner evidence found: Found 1" x 18" iron spike referred to as RR spike in above mentioned surveys.

Description of monument and accessories I established to perpetuate the original location of this corner:

In place of found 1" spike, I set a 2½" brass cap marked as shown below on 5/8" x 30" copper rod in monument box, from which;

NEW BEARING OBJECTS:

A 5/8" x 30" iron pin with  $1\frac{1}{2}$ " aluminum cap bears N33°E, 28.74 feet marked UNION COUNTY SURVEYOR NE RP.

A PK in power pole bears S63°E, 45.92 feet.


A 5/8" x 30" iron pin with  $1\frac{1}{2}$ " aluminum cap bears S14°W, 50.16 feet marked UNION COUNTY SURVEYOR SW RP.

A 5/8" x 30" iron pin with  $1\frac{1}{2}$ " aluminum cap bears N40°W, 30.19 feet marked UNION COUNTY SURVEYOR NW RP.
