Set post for 1/4 Sec. Corner, from which:

A Pine 18" in diam. bears S43°E 34 lks. dist.

A Pine 6" in diam. bears N27°W 70 lks. dist.

Description of corner evidence found:

Found the remains of the original Bearing Trees.

A Ponderosa Pine, dead and down, (original SE Bearing Tree), approximately 24" diameter and badly decayed, with scribing "1/4 S" visible on the unhealed upper blaze, the lower blaze and axe notch are visible and burnt, no scribing found.

And a Ponderosa Pine stump (original NW Bearing Tree), approximately 24" diam. at time of harvest, now rotten with a pitch core, approx. 6" diam. remaining, we open the healed remains of the lower blaze and find a scribed "T" and an axe notch.

No evidence of the original corner post remains.

Description of monument and accessories I established to perpetuate the original location of this corner:

PEGISTERED PROFESSIONAL AND SURVEYOR L. LANGLITZ

At the true corner point established at the record dimensions from the original Bearing Trees, we set a 2"x30" Aluminum Pipe, 12" in the ground to bedrock and supported in a mound of stone 4' diam. at base to top of pipe, with aluminum cap attached, marked:

The root hole of the orig. SE Bearing Tree, previously

described bears S43°E 22.4 feet,
And the stump of the orig. NW Bearing Tree, previously described, bears N27°W 46.2 feet to the the blazed face.
