At a point approx. 40 ft. North and 2 ft. East of centerline station 159+05.3 Cove-Union Highway I find a 9" x 10" x 12" stone with illegible scribes and marked with a T-post.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the intersection of the North right of way line and a line between Station 159+05.3 and the township corner (a witness point 40 North of true corner position), I set a 2 1/2" x 30" aluminum pipe as a witness corner, 29" in the ground, with a 3" aluminum cap marked as shown with a 2 ft. diam. collar of stone, from which:

NEW BEARING OBJECTS:

A 5/8" x 15" iron pin bears North $64^{\circ}23$ ' East, a dist. of 57.64 feet, with 1 1/2" aluminum cap marked UNION COUNTY SURVEYOR NE RP, from true corner position. (bears South $73^{\circ}46$ ' East, a dist. of 53.86 feet from the Witness corner). A 5/8" x 15" iron pin bears South $52^{\circ}18$ ' East, a dist. of 61.48 feet, with 1 1/2" aluminum cap

dist. of 61.48 feet, with 1 1/2" aluminum cap marked UNION COUNTY SURVEYOR SE RP from true corner position (bears South 31°56' East, a dist. of 91.43 feet from the witness corner). A 5/8" x 15" iron pin bears South 52°21' West, a dist. of 44.08 feet, with 1 1/2" aluminum cap marked UNION COUNTY SURVEYOR SW RP from the true corner position(bears South 28°21' West, a dist. of 74.13 feet from the witness

corner). A 5/8" x 15" iron pin bears North $42^{\circ}56$ ' West, a dist. of 38.32 feet, with 11/2" aluminum cap marked UNION COUNTY SURVEYOR NW RP from the true corner position (bears South $65^{\circ}40$ ' West, a dist. of 28.92 feet from the witness corner).

All references are buried 24" below ground

Falls on North side of Cove-La Grande Highway.

Set steel fence post approx. 2 ft. East and buried stone alongside






