
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

HISTORY OF ORIGINAL CORNER ESTABLISHED:

Corner was originally established under GLO contract number No. 103, dated September 3, 1963, executed David P. Thompson. Surveyor General field notes state:

Set post for 1/4 sec. corner in mound of earth with charred stake, pits, trench, as per instructions.

In Survey 28-65, James Voelz notes this corner as being along an existing fence line.



DESCRIPTION OF CORNER EVIDENCE FOUND:

None. Position falls along a shared North/South running farm road, attested by the landowners as intended to run along the line.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO REHABILITATE THE MONUMENT AT THE ORIGINAL LOCATION OF THIS CORNER:

At position by Survey, I set a 2 1/2" x 30" aluminum pipe, with 3" aluminum cap, marked as shown below, 34" in the ground and below the gravel road surface, from which:

NEW BEARING OBJECTS:

A 5/8" imes 30" iron pin bears North 46°15' East, a distance of 12.19 feet, with 1 $lat{12}$ " aluminum cap marked UNION COUNTY SURVEYOR NE RP.

A 5/8" x 30" iron pin bears South 32°37' East, a distance of 14.67 feet, with 1 ½" aluminum

cap marked UNION COUNTY SURVEYOR SE RP.

A 5/8" x 30" iron pin bears South 39°37' West, a distance of 78.98 feet, with 1 $\frac{1}{2}$ " aluminum cap marked UNION COUNTY SURVEYOR SW RP, which bears approx. 2 ft. East of a pivot stop.

A 5/8" x 30" iron pin bears North 50°50' West, a distance of 13.82 feet, with 1 $\frac{1}{2}$ " aluminum cap marked UNION COUNTY SURVEYOR NW RP.


