
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

HISTORY OF ORIGINAL CORNER ESTABLISHED:

Corner was originally established under GLO contract number No. 103, dated September 3, 1963, executed David P. Thompson. Surveyor General field notes state:

Set post for 1/4 sec. corner in mound of earth with charred stake, pits, trench, as per instructions.



DESCRIPTION OF CORNER EVIDENCE FOUND:

None. Position falls in Godley Road from which a prominent fenceline runs East

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO REHABILITATE THE MONUMENT AT THE ORIGINAL LOCATION OF THIS CORNER:

At position by Survey, I set a 5/8" x 30" iron pin, with 3" brass cap, marked as shown below, 36" in the ground and below the gravel road surface, from which:

A 5/8" \times 30" iron pin bears North 33°15' East, a distance of 26.44 feet, with 1 $\frac{1}{2}$ " aluminum cap marked UNION COUNTY SURVEYOR NE RP.

A 5/8" \times 30" iron pin bears South 36°13' East, a distance of 24.45 feet, with 1 $\frac{1}{2}$ " aluminum

cap marked UNION COUNTY SURVEYOR SE RP. A 5/8" x 30" iron pin bears South 36°57' West, a distance of 29.29 feet, with 1 ½" aluminum cap marked UNION

of 29.29 feet, with 1 ½" aluminum cap marked UNION COUNTY SURVEYOR SW RP.

A 5/8" x 30" iron pin bears North 40°21' West, a distance of 26.34 feet, with 1 $\frac{1}{2}$ " aluminum cap marked UNION COUNTY SURVEYOR NW RP.


