
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

HISTORY OF ORIGINAL CORNER ESTABLISHMENT:

Corner originally established by David P. Thompson under GLO contract Number 103, dated Sept. 3, 1863. Surveyor General record states: Set post for corner to secs 8, 9, 16 & 17 in mound of earth, pits, trench as per instructions.

Corner remonumented by J.W. Kimbrell on survey recorded in the Union County Old book of surveys on pages 110 and 111. His record states: Found no sec cor. Set stone 14x14x32 in edge of spring branch for cor to secs 8=9=16+17.

Corner searched for but not found on Union County survey number 13-86 by Gary L. Langlitz. The map of survey developed the mathematical position for this and many other corners in the township, but for some reason only monumented a select few.

No record of subsequent monumentation found in Union County monumentation records **DESCRIPTION OF CORNER EVIDENCE FOUND:**

Found no evidence of the GLO or Kimbrell corner monuments.




At the mathematical position determined by survey number 13-86, I set a $2\frac{1}{2}$ " x 30" aluminum pipe with aluminum cap marked as shown, 36 inches in the ground (6" below the surface of Union County Road Number 128), from which;

NEW BEARING OBJECTS:

A 5/8"x30" iron pin with $1\frac{1}{2}"$ aluminum cap marked S9 RP bears N 67°02'E, 30.72 feet A 5/8"x30" iron pin with $1\frac{1}{2}"$ aluminum cap marked S16 RP bears S 57°45'E, 33.70 feet A 5/8"x30" iron pin with $1\frac{1}{2}"$ aluminum cap marked S17 RP bears S 60°38'W, 22.17 feet A 5/8"x30" iron pin with $1\frac{1}{2}$ " aluminum cap marked S8 RP bears N 59°07'W, 21.81 feet
