
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner originally established by David T. Thompson under GLO contract number 103, dated September 3, 1883. Surveyor General record states: Set post for corner to secs 9, 10, 15 & 16 in mound of earth with charred stake, pits, trench as per instructions.

Oregon State Highway Division strip map number 5B-2-6 calls a position for this section corner.

Survey numbers 12-78, 5-80, 21-83, 10-84 and 31-84 use the position as called by the State Highway strip map.



No record of subsequent monumentation found in Union County survey records.

Description of corner evidence found:

Description of monument and accessories l'established to perpetuate the

original location of this corner: used by the above mentioned surveys, which falls in the centerline of State Highway 237, I set a 5/8" x 30" iron pin with plastic cap marked "BGA SURVEY MARKER", from which;

REFERENCE MONUMENT I set a $2\frac{1}{2}$ " x 30" aluminum pipe with aluminum cap marked as shown, 28 inches in the ground, North 89°32'00" East, along the North line of Section 15, 39.00 feet from the true corner monument described above.

Reference monument falls 1 ft. West of an existing fence corner with fences running North, East and Southwesterly.

Basis of bearing for reference monument is a solar observation taken at the Southeast corner of Section 16, Township 3 South, Range 40 East of the Willamette Meridian

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

THE CORNER WAS DESTROYED BY OREGON DEPARTMENT OF TRANSPORTATION (ODOT)
MAINTENANCE CREWS REPLACING THE CULVERT CROSSING STATE HIGHWAY 237 IN SEPTEMBER
2015. PRIOR TO BEING DESTROYED, THE LOCATION OF THE CORNER WAS PERPETUATED BY THE REGION 5 ODOT SURVEY CREW.

SET 1-1/2" ALUMINUM CAP ON A 5/8" X 15" IRON ROD, FLUSH WITH GROUND, MARKED AS SHOWN BELOW.


